

Panelists from the represented accrediting organizations will share insights on policies, procedures, and guidance they provide their member institutions who offer prison education programs (PEPs). This panel seeks to engage the audience in a robust discussion of "all things PEP" to include prospectus substantive change submissions, oversight entity agreements, Pell grant aspects, substantive change visits, implementation of the PEP after approval, how to create and design the best interest determination 2-years after implementation, among other topics. Conversations will touch upon accreditors' obligations and responsibilities surrounding PEPs as well as the importance of developing feedback mechanisms to member institutions and oversight entities who provide programming.

This session explores how HLC, MSCHE, SACSCOC, and WSCUC have bolstered the accreditation review process, deepened a data driven culture focused on student success, and advanced institutional improvement through the strategic use of data. Their efforts focus on providing access to learning outcomes metrics, comparisons to peer benchmarks, analyzing student post-college financial outcomes and key performance indicators that enable institutions to assess performance relative to accreditation standards and support peer evaluators.

End user adoption of metrics and tools is critical, as such, panelists will examine strategies for promoting adoption including engagement and training of constituents, and integration of data into accreditation processes. This session will also highlight how user feedback is critical to understanding how data informs institutional improvement. After the initial presentations, Mark Nicholas, Vice President, NECHE will lead the panelists in a discussion of challenges with data availability, benchmarking, post-graduation outcomes, and future directions.
